She has delivered speeches, workshops and training courses to numerous government organizations, NGOs, and the Healthcare industry at large where she is recognized as the driving force for progressive healthcare management in Hong Kong. She has actively participated in the Voluntary Rehabilitation Program launched by the Labour Department since 2003.
